## TERMS AND CONDITIONS

### 1. Included in Daily Rates

- Services of Professional Hunter and Skinner / Tracker
- Airport transfers for Phalaborwa or Hoedspruit Airports
- Luxury Accommodations, meals and laundry
- Field preparation of trophies, all permits and hunting licenses
- Beverages, including soft drinks, wine and alcohol (in moderation)
- Delivery of trophies to local taxidermist
- All taxes including VAT on daily fees and trophy fees

### 2. Not Included in Daily Rates

- Trophy Fees
- Firearm rental at \$35/day including ammunition
- Dipping and Shipping of trophies
- Gratuities
- Air fares
- Accommodation before and after the SAFARI
- Return airport transfers from Johannesburg Int. Airport \$500 / vehicle
- Day Trips and optional activities for Non-Hunters

### 3. Payment Terms

- 50 % of Daily rate/package is payable on booking confirmation
- The balance is due at the end of the SAFARI
- Trophy Fees and extras payable on departure
- Deposits are non-refundable, but can be carried over to a future SAFARI
- Dangerous game 50 % of trophy fee on confirmation
- Wounded animals to be paid as per trophy Price List

- Payments only by bank transfer, credit card or cash
- Custom made package available on request

#### 4. Hunting Days

- ODS recommends a minimum amount of days for every SAFARI, the reason being to be able to enjoy the hunt to its maximum and carefully select the best trophies.
- Plains game minimum 7 days - recommend 10 days for more than 4 larger species
- Buffalo minimum 10 days - sufficient to add additional species
- Lioness minimum 7 days - recommend 10 days to add additional species
- Lion maximum 10 days - recommend 12 days for additional species
- Elephant minimum 10 days - recommend 14 days for additional species

#### 5. Taxidermist

Whilst all reasonable precautions are taken to ensure that the quality and good care of trophies, no responsibility will be accepted by ODS for loss or damage to trophies, through fire, theft and negligence, once delivered and signed over to the taxidermist for preparation or dipping, packing and shipping.

#### 6. Safety Precautions

- Firearms will be tested on the shooting range before the SAFARI commences
- The CLIENT will act in accordance and upon instruction from the Professional Hunter as and when requested to do so.
- Firearms must be on safe mode at all times, unless otherwise instructed.

#### 7. Indemnity from Liability

- Whilst every care and precaution is taken to ensure the safety of the CLIENT it is noted that any SAFARI is potentially dangerous.
- The CLIENT hereby indemnifies ODS, its successors in title, its executors, its dependents, its staff and all associate companies, organizations, or persons acting for or on its behalf against any loss, injury and damage, whether caused directly or indirectly by delays, illness, injury, death, loss or damage of property or any other incident, including act of war, terror or riots, whether occurred as a result of negligence or not, or any expenses arising therefrom, which the CLIENT may suffer while on SAFARI with ODS.
- The CLIENT therefore undertakes to sign an Indemnity Form on behalf of him/herself and all other parties included on the SAFARI.
- Neither ODS, its successors in title, its executors, its dependents, its staff and all associate companies, organizations, or persons acting for or on its behalf shall be responsible for the loss or damage arising from any errors or omissions contained in this contract or any other ODS related literature.
- The CLIENT is required to arrange their own personal, travel, all-risks, hunting and medical insurance. The CLIENT represents and warrants to ODS that his/her physical and mental conditions is such that he/she is capable of undertaking the SAFARI.

- ODS is not responsible in any way for loss or damage to luggage or any personal effects.

**8. GENERAL**

- The CLIENT agrees that photographs and videos taken during the SAFARI may be used for promotional purposes by ODS.
- Any indulgence granted by ODS will not be interpreted as a waiver of its rights in terms of this contract.
- This contract has been drawn and will be interpreted in terms of South African law.
- Prior to departure the CLIENT shall complete and sign a trophy and shipping instruction and the Hunting Register form.
- All "special permits" for certain species will be signed by the CLIENT on arrival of the SAFARI, upon which the CLIENT accepts responsibility for the method in which the SAFARI is conducted.
- Although all SAFARI vehicles are maintained on a regular basis, ODS will not be held responsible for any breakdown that may occur.
